Format:

36-hole stroke play qualifying round, 18 holes each day, to determine 32 players for match play.

Competitors will play from the blue CWAC markers.

Ties for the last spot (s) in the match play field will be broken by a hole-by-hole play-off immediately upon completion of the second round. All announcements regarding the play-off will be made at the public scoreboard prior to the commencement of the play-off.

Prizes:

Prizes will be awarded to the Champion, Runner-up, Semifinalists, Quarterfinalists and the 36-hole Low Gross Medalist(s) from qualifying rounds.

- Practice Round Information:** Contact the Pro Shop (831) 620-8808 to arrange a practice round. For a reduced rate, and tell them you are playing in the CWAC Junior Girls' State Championship. **PLEASE NOTE:** When playing a practice round, please be courteous to the members of Quail by **playing one ball** and **maintaining pace of play**.
- Cell Phones:** Talking on cell phones is strictly prohibited on the golf course. This applies to players as well as spectators. Phones must be in silent mode at all times.
- Dress Code:** In addition to dress code on the Notice to Players, no exercise clothes, exposed midriffs or halter tops allowed. **NO JEANS ALLOWED.**
- Course Care:** Contestants must carry and use divot filler, repair ball marks and rake bunkers. Divots should be removed and placed in the rough.
- Cart/ Caddie Information:** Players must walk. No caddies.
- Practice Balls:** The range opens at 6:30 AM. Practice balls prior to your round are included in the entry fee. Players who practice after they have finished playing for the day must pay for practice balls.
- Food & Beverage Information** **Players Reception:** *Please stay and join us as we await the final scores with a bite to eat on Tuesday 6/25 beginning at 2:00 PM. The Medalist award(s) will be presented at this time.*
- Edgar's: 11:00 AM to 5:00 PM for lunch 5:00 PM to 11:00 PM for dinner.
- Covey Breakfast Restaurant Bar and Deck (located at the Lodge): 6:30 AM to 11:00 AM for breakfast and 5:00 PM to 10:00 PM for beverages and small bites.
- Payment Information:** Cash, Visa, MasterCard, Discover and American Express are accepted for all purchases (golf shop, food and beverage).
- Parking at Golf Course:** Park only in the parking lot designated for visitors. **Please do not park in the member parking lot.**
- Withdrawals, Refunds and No Shows:** Withdrawals after the closing date will be refunded 50% of the entry fee, up to 2 business days prior to the Championship. No refunds will be given for a withdrawal within 2 business days of the start of the Championship.
- To withdraw, notify Jennifer, Entries and Acceptances Chair, at JenniferNoonan@CWACgolf.org or 925-699-8731. Players who fail to notify CWAC prior to their starting time will be listed as No Shows.
- No Shows:** A player who does not show up or does not complete all rounds of the Championship for which she is eligible shall receive a one-year suspension from all CWAC events for the calendar year following the infraction.

2019 CWAC PACE OF PLAY POLICY

Stroke Play

PACE OF PLAY: Rule 5.6b states, in part: "A round of golf is meant to be played at a prompt pace," and thereafter encourages Committees to adopt a Pace of Play policy that includes penalties for slow play. In order to prevent any such penalty we suggest that you carefully review the following guidelines.

MAXIMUM ALLOWABLE TIME:

Scorecards have printed on them the **MAXIMUM** allowable time to complete the play of each hole based on a group's scheduled starting time. These times are established based on the difficulty of the course and the ability of the field. They include time to search for lost balls and deal with other common occurrences encountered during play. **A normal speed of play should result in completing play FASTER than the time indicated on the scorecard.** If a group falls behind, they must play efficient golf and make up the lost time. This might mean playing ready golf or continuous putting, which are both permitted in stroke play. **It is the PLAYERS' RESPONSIBILITY to know their group's position relative to the published Pace of Play and to ensure they play within the published limits. Failure to play within the Pace of Play guidelines will result in a penalty of two strokes.** The Rules Committee may communicate with groups throughout the round regarding their pace of play position, but are not required to do so. **THERE ARE NO OFFICIAL WARNINGS UNDER THIS POLICY.**

LEAD GROUP(S):

The lead group(s) must finish their stipulated round within the maximum allowable time established by the Committee. If they finish over their maximum allowable time, each player will be assessed **a penalty of two strokes** to their score for the final hole.

Exception:

If the lead group is delayed by play that was sent out before them or that began on the opposite tee, they will be exempt from penalty if they finish over their maximum allowable time but within **14** minutes of the group in front of them.

FOLLOWING GROUPS:

Any subsequent group must finish their stipulated round within the maximum allowable time established by the Committee. If they finish over the maximum allowable time, they must finish within **14** minutes of the group in front of them. If they finish over the maximum allowable time and more than **14** minutes behind the group in front of them, each player will be assessed **a penalty of two strokes** to their score for the final hole.

EXEMPTION FROM PENALTY:

If a group does not finish within their maximum allowable time or within **14** minutes of the preceding group due to circumstances which the Committee deems to be ***exceptional***, but was otherwise in position during the play of the final four holes, the Committee **MAY** determine not to assess the penalty.

GROUPS MAY BE MONITORED:

If a player believes that her group is being delayed by the play of another player(s) in her group, she should first address the issue with the player(s) involved. If she believes this discussion was ineffective, she may indicate to a Tournament Official on the course that she would like to have her group monitored. The Committee may also monitor a group that is failing to play within the maximum allowable time, whether or not a player has requested it. If the Committee identifies that a player(s) in the group is the cause of the group failing to maintain pace of play and determines other players are playing within the requirements of this policy, those meeting the requirements of this policy may be absolved from penalty while others may not.

UNDUE DELAY:

If the Committee determines that a group or player(s) in a group are failing to play in accordance with the established guidelines severely disrupting the play of fellow competitors or following groups, the player(s) or group may be subject to penalty for undue delay. Penalties for undue delay are independent of penalties issued under the above Pace of Play Policy (see Rule 5.6a).

The CWAC Committee reserves the right to review all penalty situations.



2019 CWAC PACE OF PLAY POLICY Match Play

Pace of Play Policy: Rule 5.6B states, in part: "A round of golf is meant to be played at a prompt pace," and thereafter encourages committees to adopt a Pace of Play Policy that includes penalties for slow play. In order to prevent any such penalty, we suggest that you carefully review the following guidelines.

Maximum Time: The maximum allowed time is the maximum time deemed necessary by the Committee for a match to complete its stipulated round. It is expressed in a per hole and aggregate time on your score card.

- a) A match's maximum allowable time begins at the assigned starting time, or if the starting time is delayed, at the adjusted start time.
- b) Time associated with playing the game, e.g. course difficulty and walking times between holes, is included in all maximum allowable times.

Out of Position: The first match to start will be considered out of position if, at any time during the round, the match is behind the prescribed schedule as determined by the Committee. Any following match will be considered out of position if it:

- a) Is taking more than the allotted time to play **AND**
- b) Reaches the tee of a **par-3** hole and the preceding match has cleared the next tee.
- c) Reaches a **par-4** hole and becomes clear of play before any player plays a stroke from the teeing area; or
- d) Reaches a **par-5** hole after any player in the group ahead has made a stroke from the putting green.

Match Out of Position: If a match is out of position, the players in that match may be timed.

Timing:

- When the Committee determines that a match will be put "on the clock", the players will be notified by a Rules Rover.
- Each player is permitted a maximum of 40 seconds to make a stroke. A player who exceeds 40 seconds is considered to have made a bad time and will be informed as soon as possible.
- Except on the putting green, the timing of a player's stroke begins when it is the player's turn to play without interference or distraction. Time spent determining yardage and other conditions, such as wind, will count as time taken for the stroke.
- On the putting green, the timing of a player's stroke begins when it is the player's turn to play without interference or distraction and after a player has completed the actions allowed under Rule 13.1, providing the player is not unreasonably delaying play. Time spent surveying the line of play from any angle will also count as time taken for the stroke.
- When "on the clock", the Committee may assess a bad time to a player who delays play between shots or holes.
- The Committee reserves the right to put a match, or individual player "on the clock" regardless of whether the match is out of position.
- A Rules Rover may not tell a group when it has regained its position and is no longer "on the clock". A player may inquire of the match's status at any time.

Pace of Play Penalties: The following is the penalty structure for players who receive bad times while being timed("on the clock"):

- **1st bad time - Warning**
- **2nd bad time - Loss of hole penalty**
- **3rd bad time - Loss of hole penalty**
- **4th bad time - Disqualification**

NOTE: If the match in question regains its proper position, any previous bad times will be carried over for the remainder of that round. Any player who incurs bad times(s) will be reminded of the bad time(s) if the player or match requires additional timing.

Rulings or Other Incidents: If a ruling or some other legitimate delay occurs which causes the match in question to lose its position, that match is expected to regain its position within a reasonable time.

The CWAC Committee reserves the right to review all penalty situations.

Notice to Players — DRAFT

The Rules of Golf as approved by the USGA and The R&A govern play. The following Local Rules and Terms of the Competition are in effect. Complete text of Rules and Model Local Rules may be found in the current edition of the *Official Guide to the Rules of Golf*.

This information supplements the Championship Information.

Unless otherwise noted, the penalty for breach of a Local Rule is the general penalty.

Tee Markers: Play will be from the Blue CWAC markers wherever they are placed.

Scorecard: The Quail Lodge & Golf Club scorecard and yardage book are unofficial and have no status in the competition.

Ties: Stroke Play – In the event of a tie for last (32nd) spot after 36 holes of stroke play, there will be a hole-by-hole playoff immediately following the completion of the second round. All announcements regarding the playoff will be made at the public scoreboard upon completion of the second round.

Seeding for Match Play: Ties in stroke play will be decided by blind draw, except that places of those participating in the play-off will be determined by performance in the play-off and then by the order of the public scoreboard.

Transportation: Motorized transportation is prohibited Model Local Rule G-6. **Spectator carts are not allowed.**

Caddies: Model Local Rule H-1.1 is in effect prohibiting the use of caddies.

List of Conforming Driver Heads: Model Local Rule G-1 is in effect.

Replacement of a Broken or Significantly Damaged Club: Model Local Rule G-9 is in effect.

Aeration Holes: Model Local Rule E-4 is in effect.

Seams of Cut Turf (Sod Seams): Model Local Rule F-7 is in effect.

Ground Under Repair: Defined by white lines. French drains are ground under repair.

Loose Impediments: The decorative wood chips throughout the course are loose impediments.

Out of Bounds: Defined by inside points at ground level of white stakes, white lines, perimeter fences, inside edges of curbs with OB markers on them or course-side edge of all other roadways throughout the course. With the exception of the road that crosses the 14th hole, Model Local Rule A-3 is in effect for a ball crossing a public road and coming to rest on another part of the course.

Penalty Areas: When a penalty area is defined on only one side, it extends to infinity. When a penalty area is connected to the out-of-bounds edge, the penalty area extends to and coincides with out of bounds.

- a. In the play of **Hole #11**, the Yellow Penalty Area in the front portion of the 12th Tee is deemed to be a Red Penalty Area.

Dropping Zones: Dropping zones have been provided as an ADDITIONAL relief option on the following holes:

- a. **Hole #5** – For a ball which enters the penalty area to the right of the green. Relief under Rule 17.1 or Dropping Zone.
- b. **Hole #14** – For any unplayable ball beyond the cart path behind the green. Relief under Rule 19.1 or Dropping Zone.

Code of Conduct – Play of 16th Hole: During the play of the 16th hole, a player must not deliberately hit the ball from the teeing area onto the 15th hole. Penalty for Breach: **Disqualification**. The white stakes between holes 15 and 16 have no status in the competition; relief may be taken under Rule 16.1.

White-Lined Areas Tying Into Artificially-Surfaced Roads and Paths: White-lined areas of ground under repair and the artificially-surfaced roads, paths or other identified obstructions that they are connected to are a single abnormal course condition when taking relief under Rule 16.1.

Stopping and Resuming Play: Model Rule J-1 is in effect.

- **Immediate Suspension: One prolonged blast of the horn**
- **Normal Suspension: Three consecutive blasts of the horn**
- **Resumption of Play: Two short blasts of the horn**

All practice areas will be closed under an immediate suspension of play until the Committee declares them open.

Practice: Prior to and after a round in stroke play, a player may practice on designated practice areas. Rule 5.2b covering practice in stroke play is modified in this way: A player may not practice on the competition course before or between rounds. Penalty for breach of Local Rule, see Rule 5.2.

Terms of the Competition

Scoring Area: Located in the Oak Room. The scorecard is officially returned when it has been left with the Committee and the player has left the scoring room.

Close of Competition: A competition is deemed to have closed when the result has been officially announced or in stroke play qualifying followed by match play when the player has teed off in her first match (Rule 20.2e(2)). The result of a match is considered to have been “officially announced” when the Committee has approved the result as posted on the public scoreboard.

Dress Code: Players and spectators must be properly attired both on the course and on the premises of the club. Jeans, blue or designer, t-shirts and tank tops are prohibited. A player violating this dress code will not be permitted to start the competition. A violation during the round must be rectified without undue delay or the player will not be permitted to continue.

Serious Misconduct: Disruptive or inappropriate behavior contrary to the good conduct of the championship in the determination of the Committee will not be tolerated. Examples include (but are not limited to): club throwing, offensive language, willful damage to the course/club, verbal abuse of the course, staff, officials, volunteers, host club staff or other contestants, or potential endangerment of others. The penalty for a Serious Misconduct is Disqualification.

Pace of Play: See separate Pace of Play Policy.

Final decision on any disputed points will be made Yole Whitlock, Joan Caldwell, Janine Martello, Kate Washburn, and Ryan Dunham.
